### DECISION No 04/2020 OF THE DIRECTOR OF CEITEC BUT

#### Change of emergency measures for students at CEITEC BUT in connection with coronavirus spread

Based on the Government Resolution of 23 April 2020 and the Emergency Measure of the Ministry of Health of the Czech Republic dated April 15, 2020, I am relieving the regime of personal presence of students at CEITEC BUT (hereinafter referred to as "students") as follows.

The ban on the personal presence of students at classes at the BUT CEITEC campus remains in force, and I allow the following exceptions for students of all years of doctoral studies in the AMN CEITEC study program and for bachelor's and master's degree students of BUT faculties:

- laboratory or experimental work related especially to the doctoral dissertation in the presence of a maximum of 5 people,
- laboratory, experimental or implementation work related especially to the bachelor's or master's thesis in the presence of a maximum of 5 persons,
- consultation or testing in the presence of a maximum of 5 persons,
- practical instruction and practice.

Students may participate in the above-mentioned forms of teaching or other activities in the CEITEC BUT premises only if the following conditions are met:

- student has been free from acute medical conditions corresponding to viral infectious diseases (e.g. fever, cough, shortness of breath, sudden loss of taste and smell, etc.) in the last 14 days,
- student has no quarantine measures at any given time;
- therefore **every day before the first entrance to the CEITEC BUT object, the student electronically confirms his/her declaration of honour about the absence of symptoms of viral disease (form attached) in the BUT STUDIS information system at <https://vut.cz/bezinfekcnost>**, electronic confirmation can be replaced by a completed

and signed written declaration in the attachment form, which the student will hand in at the reception in Building S upon arrival,

- hand disinfection when entering the object / room (disinfectant is provided by CEITEC BUT),
- it is recommended that the number of students in the working group be limited as much as possible to a maximum of 5 and that the composition of the working groups be kept as stable as possible;
- respiratory protective equipment (drape, scarf, etc.) must be worn if operating conditions allow it.

Until the end of the emergency measures, the CEITEC BUT Operations Department shall ensure the availability of disinfectants at the entrances to the CEITEC BUT premises (buildings) and, if possible, in teaching rooms and laboratories with student access.

It is still possible for all persons who work here on the basis of an employment contract to enter CEITEC BUT, even if they are CEITEC BUT students at the same time.
